Chief Water Treatment Plant Operator 1-B Plant

Job Class – Competitive (test required)

The Village of Tarrytown is seeking to fill the position of Chief Water Treatment Plant Operator 1-B Plant in the Water Department. This is a Civil Service Competitive-Class position, which means a test is required. It is covered by the local Tarrytown CSEA agreement. We seek a candidate who meets the requirements of Civil Service as well as the County and NYS Health Depts., and the requirements of Subpart 5-4 of the NYS Sanitary Code, and has two (2) years or more of supervisory experience in the operation, maintenance, design or repair of water works facilities. A special requirement applies that requires the possession of a current Water Treatment Plant Operator 1-B Certificate issued by the NYS Health Department under the provisions of Subpart 5-4 of the NYS Sanitary Code at the time of appointment. Thorough knowledge is required of the practices used and equipment required in the operation of a Type 1-B Water Treatment Plant containing various water treatment facilities and equipment. A Type 1-B Water Treatment Plant is capable of handling over 2.5 million gallons of water per day. This is an important supervisory and technical position involving responsibility for the safe and efficient operation and maintenance of a Type 1-B Water Treatment Plant and its facilities and equipment.

Salary is commensurate with experience and is in the range of \$94,154 - \$114,504, DOQE. This position is eligible for and regularly scheduled for overtime as well as for stand-by pay as part of the normal compensation, under memorandum of agreement between the union and the Village.
